#### **Registration Policy**

- ï Registration will only be confirmed after this form is returned and payment is received in full.
- ï Registration will be limited by class size, the pre-requisite class requirements, and for certain classes approval by the Colossal Tennis directors.

#### **Payment Policy**

ï Payment must be received in full prior to the start of the current session.

#### **Cancellation Policy**

- ï A full refund will be provided only if the request for cancellation to a Colossal Tennis session program is provided in writing at least 7 days prior to the beginning of the first class of the session.
- Colossal Tennis reserves the right to cancel classes due to insufficient registration. If a class is cancelled, Colossal Tennis will find another class time for your child. If a suitable alternative class can not be found, payment received prior to the start date will be refunded in full.

#### Make-up Policy

- There are no refunds, prorating, or credits provided for missed classes.
- ï No make-ups will be provided for classes missed by participants.

## **Inclement Weather Policy**

- If inclement weather leads to the cancellation of outdoor class, every attempt will be made to secure an indoor tennis court replacement. If no indoor tennis court space can be arranged Colossal Tennis will attempt to secure space to conduct fitness training, mental training, and video analysis instruction indoors.
- ï If no indoor space can be secured, a credit will be provided for an alternate class for use in the current session only.

## **Release of Liability**
